The rules governing hiring of constituency office staff

- A Member may employ any number of persons in his main constituency office. However, the total sum allocated for salary payments in a Constituency Office does not exceed \$45,700.00 per month.
- While payments are made directly to the bank account of the employee by the Office of the Parliament, it is the Member of Parliament who recruits employees, and instructions on the quantum of an employee's salary are also issued by the Member.
- In Constituencies where Sub-Offices have been approved, Members are permitted to employ a maximum of three (3) persons at a combined salary of \$5,000.00 per month. Sub-Offices can be operated on a part time basis and therefore staff of a Sub-Office may be employed as part-time employees.
- The Member of Parliament is the employer of persons at the Constituency Office, and not the Office of the Parliament. In this regard, although Members of Parliament may, from time to time, seek assistance from the Office of the Parliament with the preparation of job descriptions, they have the sole authority and discretion to employ, promote and terminate employees, assign hours of work and formulate job descriptions.
- Members are advised that no employee shall be paid below the national minimum wage, which is \$15 per hour.

Members are also restricted from employing relatives as employees in their constituency offices.
